Program Name: Broadband Equity, Access, and Deployment Program (BEAD)

- Cooperatives

Eligible Projects

 Qualifying last-mile broadband projects to unserved (25/3 Mbps or less) and underserved (between 25/3 and 100/20 Mbps) locations

Eligible Areas

- Eligible locations will be grouped by Census Block Groups (CBG's)
- Applicants must serve all eligible locations within a selected CBG
- Applications with multiple CBG's must be conitiguous (sharing a border or corner)

Eligible Costs

- Construction, improvement, and/or acquisition of facilities and telecommunications equipment, infrastructure for backhaul, middle and last-mile networks, and MDUs
- Long-term leases of facilities to provide qualifying broadband service, including IRUs
- Deployment of internet and Wi-Fi within an eligible multi-family residential building
- Network software upgrades
- Engineering design, permitting, and work related to environmental, historical, and cultural reviews
- Personnel costs, including salaries and fringe benefits for staff and consultants
- Training for cybersecurity professionals working on BEAD-funded networks
- Workforce development including Registered Apprenticeships and pre-apprenticeships, and community college and/or vocational training for broadband-related occupations

Selection Criteria

Scoring (maximum of 100 points): Primary criteria

- Minimal BEAD Outlay (up to 40 points): Score assessed based on how high or low applicant's grant request is relative to the reference subsidy for the CBGs
- **Affordability (up to 25 points):** Score assessed on how high or low commitments are relative to the reference prices for the tier of service:
 - Priority bids (1/1 Gbps service): \$85 per month
 - o Non-priority bids (100/20 Mbps service): \$37 per month
- Fair Labor Practices (up to 10 points): Applicants will receive 10 points for demonstrated compliance with federal labor laws over the last three years and providing forward-looking plans to comply. Applicants without three years of operational experience can receive 10 points by signing a certification of future compliance and providing forwardlooking plans to be in compliance

Selection Criteria (cont'd)

Secondary criteria

- **Speed Deployment (up to 3 points):** Timelines should span no more than 48 months from date applicant receives notice of final award. Timelines shorter than 24 months receive 3 additional points
- Speed, latency and other technical issues (up to 2 points):
 - 2 points for bids to deploy XGS-PON fiber technology
 - 1.5 points for bidgs to deploy non-XGS-PON fiber technology
 - o 1 point for 1000/500 Mbps non-fiber technology
 - .5 point for 400/200 Mbps non-fiber technology
 - o **O points** for technology with more than 100 milliseconds of latency

Additional criteria

- Workforce support (up to 5 points): Points awarded based on workforce support plans
- Scale of geographic coverage (up to 5 points):
 - o **5 points** for covering 100% of eligible locations within a CBG
 - 5 points for covering up to 3000 locations within a selected CBG
 - 4 points for covering up to 2000 locations within a selected CBG
 - o **3 points** for covering up to 1500 locations within a selected CBG
 - 2 points for covering up to 100 locations within a selected CBG
 - 1 point for covering up to 500 locations within a selected CBG
- Inclusion of zero-bid CBG's (up to 5 points): Points awarded based on the number of zero-bid CBGs included in their tranche two bid. Each zero-bid CBG will be worth one-half point
- **Local Coordination (up to 2.5 points):** Applicants encouraged to submit letters of support from local governments, applicants receive a half point for each letter, up to 2.5 points maximum
- Weather resiliency (up to 2.5 points): Applicants will receive points based on weather resiliency measures
 - 1 point for plans to bury at least 85% of fiber
 - o **1 point** for a weather mitigation plan
 - .5 point for committing to attend municiple emergency management meetings
