#### **Eligible Applicants**

- Entites that can deploy broadband are eligible to apply. Eligible entities include but are not limited to:
  - Cooperatives
  - Nonprofit Organizations
  - Public-Private Partnerships
  - Private Companies
  - Public or Private Utilities
  - Public Utility Districts
  - Local Governments

## **Eligible Projects**

 Wave 1 eligiblity: Applications where 10% or more of the proposed Project Area is composed of Hard-to-Serve Project Area Units and that are Priority Broadbrand Projects (end-to-end fiber)

## **Eligible Areas**

• Project Area Units (PAU's) were determined by the broadband office

# **Eligible Costs**

- Construction, improvement, and/or acquisition of facilities and telecommunications equipment, including infrastructure for backhaul, middle and last-mile networks, and multi tenant buildings
- Long-term leases of facilities to provide qualifying broadband service, including IRUs
- Deployment of internet and Wi-Fi within an eligible multi-family residential building
- Network software upgrades
- Engineering design, permitting, and work related to environmental, historical, and cultural reviews
- Personnel costs, including salaries and fringe benefits for staff and consultants
- Training for cybersecurity professionals working on BEAD-funded networks
- Workforce development including Registered Apprenticeships and pre-apprenticeships, and community college and/or vocational training for broadband-related occupations

# **Selection Criteria**

# Scoring (maximum of 100 points): Primary criteria

- Minimal BEAD Outlay, Non-State match (up to 20 points): Points awarded based on the degree to which non-state match exceeds 30%
  - o 60% or more 20 points
  - o 55-59.9% 17 points
  - o 50-54.9% 14 points
  - 45-49.9% 11 points
  - 40-44.9% 8 points
  - o 35-39.9% 5 points
  - o 30-34.9% 2 points
  - Less than 30% 0 points

#### **Selection Criteria (cont'd)**

- Minimal BEAD Outlay, Financial Need (up to 30 points): Points awarded on the percentage of the amount requested vs State's published reference cost
  - 0 19.9% 30 points
  - o 20-39.9% 27 points
  - 40-59.9% 24 points
  - o 60-79.9% 21 points
  - o 80-99.9% 18 points
  - o 100-119.9% 15 points
  - o 120-139.9% 12 points
  - o 140-159.9% 9 points
  - o 160-179.9% 6 points
  - o 180-199.9% 3 points
  - 200 % or more 0 points
- Affordability (up to 15 points): Points awarded on a calculation to determine the
  difference in the commitment and the reference price of \$100 for 1G/1G, Priority
  Broadband projects and \$30 for Other Last-Mile Broadband Deployment projects
  - 7.5 to 15 points: For applications offering a price lower than the reference price, there will be an upward adjustment to the baseline score of 7.5
     Score = 7.5 + 7.5 \* [(reference price commitment price) / reference price]
  - 0 to 7.5 points: For applications offering a price higher than the reference price, there will be a downward adjustment to the baseline score of 7.5 minimum Score = 7.5 7.5 \* [(commitment price reference price) / reference price]
- Fair Labor Practices (up to 15 points):
  - 7 points Submission of a Project Labor Agreement (PLA)
  - 5 points No prior violations of compliance with federal labor and employment laws
  - 3 points Forward looking commitments to comply (with claw-back provisions)

### **Selection Criteria (cont'd)**

#### Secondary criteria

- Speed Deployment (up to 3 points):
  - 3 points given for completing the build within 2 years
  - o 0 points given for completing the build within 4 years
- Network Speed & Latency (up to 4 points):
  - 4 points for 1Gbps/1Gbps and 100ms max latency
  - 2 points for 100/100 Mbps and 100ms max latency
  - o 0 points for 100/20 Mbps and 100ms max latency
- Open Access and Use of Existing Network (up to 3 points): Scoring on the submission of evidence for three categories:
  - 1. Description of wholesale services offered and associated rates
  - 2. Evidence of retail ISP partners
  - 3. Evidence of publicly available open access policy
    - 3 points for qualifying evidence in all 3 categories
    - o 2 points for qualifying evidence in 2 of the 3 categories
    - o 0 points for qualifying evidence in less than 2 categories
- Local Coordination Evidence of community support (up to 5 points): Points awarded for the depth and breadth of community support shown for project
- Local Coordination Verified financial commitment (up to 5 points): Points
   awarded based on level of financial investment by community members and organizations

#### **Application Process**

- Applicants must be registered in the <u>Grant Accountability and Transparency Act (GATA)</u>
   Portal at the time of application
- Airtable and Smartsheet submission platforms will be used, templates for submission can be found in the <u>Application Guidebook</u>
