Eligible Projects

• **Priority Broadband Projects are:** Applications that propose to construct end-to-end fiber-optic facilities to all unserved and underserved BSLs in a Project Funding Area

Eligible Areas

Broadband office defined application areas are posted at <u>ded.mo.gov/office-broadband-development/mapping</u> under the "Application Areas" heading

Eligible Costs

- Construction, improvement, and/or acquisition of facilities and telecommunications equipment, including infrastructure for backhaul, middle and last-mile networks, and MDUs
- Long-term leases of facilities to provide qualifying broadband service, including IRUs
- Deployment of internet and Wi-Fi within an eligible MDU residential building
- Network software upgrades
- Engineering design, permitting, and work related to environmental, historical, and cultural reviews
- Personnel costs, including salaries and fringe benefits for staff and consultants
- Training for cybersecurity professionals working on BEAD-funded networks
- Workforce development including Registered Apprenticeships and pre-apprenticeships, and community college and/or vocational training for broadband-related occupations

Selection Criteria

Scoring (maximum of 320 points):

Primary criteria

- Minimal BEAD Outlay (up to 100 points):
 Score = 100 [percent of outlay requested² / 100]
- Affordability (up to 100 points):
 - Competitive Areas: Score = Urban Rate Survey 2023 Benchmark for 1 Gbps/1
 Gbps [monthly price of Applicant's 1 Gbps/1Gbps plan]
 - NonCompetitive Areas: applicants that commit to charge less than the 2023 Urban Rate Survey Benchmark price for 1 Gbps/1 Gbps service will receive 50 points and if ISP charges no more for equivalent service in non-BEAD areas will receive an additional 50 points for a possssible total of 100 points Applicants that decline to make either commitments receive 0 points
- Fair Labor Practices (up to 40 points):
 - For subgrantees with three years experience
 - 10 points Disclosure of violations
 - 10 points Disclosure of safety records
 - 10 points Workforce plan
 - 10 points Workplace safety
 - For subgrantees without three years experience
 - 20 points Workforce plan
 - 20 points Workplace safety

Secondary criteria

- **Speed Deployment (up to 18 points): the highest points** awarded to projects serving every location within 18 months. For example:
 - o 18 points given for completing the build within 18 months
 - o 0 points given for completing the build within 45 months
- Local Coordination (up to 20 points):
 - 20 points local financial support shown
 - o up to 16 points non financial levels of support shown
- Training Commitments (up to 10 points)
- Hiring Commitments (up to 10 points)
- Employment Commitments (up to 10 points)
- Missouri Economic Development (up to 12 points)

Selection Criteria (cont'd)

Non-Priority Broadband Projects Only

- Minimal BEAD Outlay (up to 100 points):
 Score = 100 [percent of outlay requested² / 100]
- Affordability (up to 100 points):
 - Score = (Urban Rate Survey 2023 Benchmark for 1 Gbps/1 Gbps monthly price of 1 Gbps/1Gbps plan for locations served by fiber) x percentage of locations served by fiber + (Uban Rate Survey 2023 Benchmark for 100/20 Mbps monthly price of 100/20 Mbps for locations served by a non-fiber technology) x percentage of locations served by a non-fiber technology
- Fair Labor Practices (up to 40 points):
 - For subgrantees with three years experience
 - 10 points Disclosure of violations
 - 10 points Disclosure of safety records
 - 10 points Workforce plan
 - 10 points Workplace safety
 - For subgrantees without three years experience
 - 20 points Workforce plan
 - 20 points Workplace safety

Secondary criteria

- **Speed Deployment (up to 13.5 points): the highest points** awarded to projects serving every location within 18 months. For example:
 - o 13.5 points given for completing the build within 18 months
 - o **O points** given for completing the build within 45 months
- Speed of Network and Other Technical Capabilities (up to 20 points):
 - Up to 8 points Speed
 - Up to 4 points Latency
 - Up to 4 points Useful Life
 - Up to 4 points Scalability
- Local Coordination (up to 15 points):
 - o 15 points local financial support shown
 - up to 12 points non financial levels of support shown
- Training Commitments (up to 7.5 points)
- Hiring Commitments (up to 7.5 points)
- Employment Commitments (up to 7.5 points)
- Missouri Economic Development (up to 9 points)
